Resignation of Commissioner Barrett and filling the remainder of her term (12/31/2013)

President Achziger contacted Commissioner Barrett regarding her expected attendance at the meetings remaining in her term. As a result of that conversation, Commissioner Barrett agreed that she was unable to meet the expectations of the office she was elected to due to her job duties and opted to resign in the best interests of the citizens of Des Moines. She submitted a letter of resignation, effective September 10, 2013. President Achziger thanked and commended her for her service.

Commissioner Martinson moved to accept Commissioner Barrett's resignation; Commissioner Kasnick, second. The motion passed, 4-0.

Position #3 is being sought by candidate Schell Ross and will take her oath of office, after the November 5 election is certified on November 26, 2013. Toni Overmyer has been attending meetings and is more acclimated to the Board at this time. Therefore, President Achziger proposed appointing Toni to take Position #3 until such time as the election is certified when Schell will assume the position.

Commissioner Kasnick moved to appoint Toni Overmyer to Position #3 of the Des Moines Pool Metropolitan Park District Board of Commissioners until November 26, 2013, effective September 10, 2013; Commissioner Martinson, second. The motion passed, 4-0.
