MINUTES

**CALL TO ORDER/PLEDGE OF ALLEGIANCE/ROLL CALL** The meeting was called to order by President Achziger at 5:02 p.m. Commissioner Kasnick led the flag salute.

**BUSINESS**

**Living Allowance for Rodger Bennett, District Manager Candidate**

Rodger Bennett has accepted the position as District Manager and has requested a partial living allowance of \$650 per month as he will have to maintain living arrangements when on assignment with the District. Prothman Company confirms that this is a common request when contractors are working beyond a typical commute distance. The Marina Inn motel (in Des Moines) room rate is \$55 plus tax/night. Local apartment rental websites indicate rents starting at \$750 for a studio apartment.

Commissioner Kuehnoel moved that the District authorize a payment of \$650 per month for a living allowance for Rodger Bennett, newly hired District Manager, for each month the District contracts for his services with Prothman Company, not to exceed 12 months, and subject to 90-day performance reviews with Mr. Bennett; Commissioner Kasnick, second. The motion passed, 5-0.

**2014 Philips Publishing Contract for Normandy Park City Scene**

At the regular meeting on October 1, 2013, District Commissioners voted to enter into an advertising contract with Philips Publishing for the Des Moines *City Currents* at a reduced annual rate. The subsequent contract for a reduced annual rate with Normandy Park *City Scene* was not available at that time.


Commissioner Ross moved to authorize the President of the Commission to enter into a contract with Philips Publishing in the amount of \$765.00 for advertising in the Normandy Park *City Scene* for 2014; Commissioner Kasnick, second. The motion passed, 5-0.
