A slide presentation was shown by the BRS team of Keith Hayes, Carmen Arriaga-Bucher, and Ken Ballard from Ballard King & Associates. The presentation is on file.

Topics covering user preferences regarding a pool or community center environment ranged from competitive environments to water temperature, as well as multi-generational features.

An audience participation exercise entitled "Dot-ocracy" was introduced and asked for users' to indicate their top 5 feature choices on posters around the meeting room.

Questions and comments were entertained from the audience; and included operating costs, specialty rooms included in a future facility, the differences in water temperatures for various water activities, facility sites, sustainability, timeframe for development of a new facility, and collaboration with other cities.

Information regarding the use of survey cards and the target audience within Des Moines was discussed. President Overmyer added that the goal is to obtain an unbiased opinion.


