MINUTES

CALL TO ORDER/ROLL CALL

President Overmyer called the meeting to order at 3:00 p.m. Present were Commissioners, Dusenbury, Kasnick, and Martinson; Keith Hayes and Carmen Arriaga-Bucher from BRS; DGM Deschenes and District Clerk Linda Ray. Commissioner Dusenbury moved to excuse Commissioner Kuehnoel who was absent; Commissioner Kasnick 2nd. Passed 4-0.

PRESENTATIONS BY BRS

Carmen Arriaga-Bucher confirmed the purpose of the meeting and the desired outcome.

Keith Hayes entertained questions and comments from the Board members with regard to Ron Vine's presentation of the survey results presented at a Special Meeting on July 25th. It was reinforced that there was a 95% confidence level based on 296 completed surveys. The full BRS presentation is on file.

BRS presented information on project stakeholder groups which include the Highline School District, area hospitals, the City of Des Moines and senior services.

An explanation of Support Spaces; i.e. wish list, base program and extended program features was offered by BRS and was explained as what the Board has asked for, the wish list tweaked, and all extras and add-ons. Additional information on program budget in each category was discussed, as well as cost of remodeling Mt. Rainer Pool on its current site. It was stated that a remodel project would be challenging due to site constraints which might trigger other issues. The Board continued the discussion by asking if a spend of an additional \$5M in repair and renovation costs on the current facility was prudent due to its age.

It was agreed that the information that BRS and the Board set out to obtain had been achieved. The question of "stay or go" still needs to be addressed.

A review of potential sites was narrowed down to three 4 to 5-acre options which includes the current site.

Potential aesthetics were presented to the Board and they were asked for their feedback
