MINUTES

President Overmyer called the meeting to order at 6:30 p.m. and introduced District General Manager Deschenes to the attendees. DGM Deschenes explained the history of the special district and purpose of the public meeting.

Keith Hayes from BRS offered a presentation and explained their involvement in the aquatic feasibility study. It was stated that the study and public meetings are meant to educate, explore, and engage the community while asked for community feedback in order to refine preliminary programming.

Keith directed his comments to the survey results and the Mt. Rainier Pool, stating the facilities main usage. Survey results indicated that 6% of respondents rated the condition of the facility as excellent, and that 72% indicated they would like to see a combination space. He also reviewed survey results vs public responses received at Public Meeting #1 to Dot-ocracy.

Questions from the meeting attendees covered subjects on amenities and parking, whether the current facility would remain in its current location, and whether or not a renovation or new facility would be considered.

BRS continued their presentation with regard to survey results, site analysis, and aesthetics. A copy of the full presentation is on file.

Feedback from attendees included cost considerations, the look and feel of a new building and that it should fit in with the nautical theme of the area, time frame for a new build, and the potential for a LEEDs facility.

A representative from the YMCA in attendance indicated that a new project in Kent was being developed nearby. President Overmyer indicated that she had attempted to contact the Y to discuss the study.

Keith Hayes concluded the meeting by stating that more defined site information would be offered at Public Meeting #3 on September 13th.

District General Manager Deschenes informed the attendees where to find information on-line; i.e. website and social media, and how to sign up for newsletters.

A final comment was made by an attendee about a potential tour of other facilities for the public. President Overmyer that the subject would be considered and discussed at the next public meeting.
