MINUTES SPECIAL MEETING

CALL TO ORDER/ROLL CALL

President Overmyer called the meeting to order at 4:30 p.m. Present were Commissioners, Dusenbury, Achziger, and Young; Aquatic Manager Dominic Finazzo, DGM Deschenes, and District Clerk Linda Ray. Commissioner Kasnick joined the meeting after roll call.

BUSINESS

Presentation

Commissioner Achziger presented the King County initiative, "Best Starts", to promote learning among young children and bridge gaps between socio-economic and racial groups. King County is looking for proposals on programs to help children get off to a good start. One more proposal is needed. Commissioner Achziger met with Bernie Dorsey regarding opportunities for swim lessons. An Australian study found that children learn best if before kindergarten age and are ahead of their peers by as much as 20 months, particularly in math and in instruction comprehension. Ages 5 to 8 are prime for learning to swim. Kids who have struggles with hand eye coordination are much improved after swimming.

King County is interested to know if we want to participate. There is already a group in Burien working with Evergreen.

A discussion regarding transportation of children from pre-schools and day cares ensued along with the need for parental participation. The Aquatic Manager would need want information on what is being asked of his staff in order to facilitate the program. He also stated that he could not guarantee he would have staff capacity in order to cover the program.

Commissioner Achziger explained that the contract term starts on October 1, 2018 and goes through December 2020. The 1st phase is for planning and the program would roll out next summer. Thirteen grants will be offered.

President Overmyer suggested a letter to Highline School District stating our interest based on staffing to determine if we can participate. Commissioner will provide a contact name and address.
