Job Title: Water Safety (Swim Lesson) Instructor Reports to: Aquatics Coordinator & Aquatics Manager Classification: Hourly, part-time, up to 20 per week Compensation: \$15.78 to \$19.20 per hour, depending on experience Deadline: Open Continuously.

Overview:

Under direction from designated supervisor(s), conduct a wide variety of swimming, diving, water exercise, and specialty aquatic activities at a busy community swimming pool. Responsible for patron life safety, patron surveillance, instruction (e.g. teaching swimming lessons, leading water exercise classes, etc.) supervision, record keeping, completing progress reports, and other tasks as assigned. Must be familiar with American Red Cross water safety standards, provide water safety education, enforce safety rules, and respond to emergencies and difficult situations in an appropriate manner. Must be responsible, trustworthy, and able to work independently without direct supervision or as part of a staff team. This position may be required to work special events, evenings, weekends, and split shifts.

Supervision:

Works under the guidance of the Aquatics Coordinator and supervision of the Aquatics Coordinator and the Aquatics Manager.

Essential Job Functions:

- Prevent accidents and injuries through patron surveillance, rule enforcement, and water safety education.
- Respond to all emergencies, including active drowning victims and other lifethreatening situations. Report any injuries, incidents, or damage using appropriate forms.
- Communicate well with other Aquatics staff to ensure the safety of patrons and smooth operation of aquatic activities. Communicate any concerns or problems regarding safety, patrons, activities, the facility, or personnel to a supervisor.
- Conduct classes according to program guidelines. Ensure safety of students/participants during class time. Assist other instructors, as necessary.
- Plan and organize activities, including the use of block and lesson plans.
- Provide positive motivational and corrective feedback to students/participants.
- Complete and distribute progress cards, according to program.
- Provide high-quality customer service.
- Complete mandatory and assigned trainings.
- Maintain all required certifications.

Non-Essential Job Functions:

• Perform other duties of a similar nature, as assigned.

Qualifications:

- Aquatic programs; swimming lessons, water exercise, etc.
- District's policies and procedures.
- Teaching techniques and methods.
- First Aid and CPR.
- Lifeguard techniques and principles.
